TERMS AND CONDITIONS:

Celebrations will provide professional DJ/KJ services (the Entertainer) on the date, times and location specified on page 1 (the Event). Entertainer will provide the appropriate and adequate equipment and music for the Event. Client prefers that Derrick M. Muñoz be the Entertainer for the Event, but Client understands that Celebrations has the option and ability to substitute a comparable Entertainer for the Event.

Client will provide sufficient space at the Event for Entertainer and equipment. Client will also provide a grounded 15 amp electrical outlet to which no other equipment has been connected (dedicated circuit). Neither Celebrations nor Entertainer shall be responsible for any electrical problem or failure, unless same is directly caused by the actions of Entertainer or equipment thereof. Client agrees to provide adequate security and compensate Entertainer and Celebrations for any injuries, damages, intentional or otherwise, to Entertainer or equipment caused by Client, Event attendees or incidents at the Event.

Client will indemnify, defend, and hold both Celebrations and Entertainer harmless from any and all claims, demands, losses, proceedings, expenses, or other liabilities, including attorney's fees, arising out of or resulting from the performance of this contract.

Celebrations is not obligated under this contract until a representative from Celebrations has signed this contract. To reserve the date for the Event, you will need to consult with a Celebrations representative, return this signed contract and provide a non-refundable **50% deposit**.

The **complete balance** is the earlier of 30 days after the deposit payment or two weeks prior to the event by personal check or cash. **Make all checks payable to: Derrick M. Munoz**

Cancellations made less than 90 days before the Event will be subject to payment of one-half of the total contract fee. Cancellations made less than 60 days before the event will be subject to the total contract fee. Credit for cancellation fees may be given at Celebrations discretion.

All date changes for the Event are subject to Celebrations discretion and will be considered a cancellation if Celebrations is unable to provide an entertainer for the new date. Date changes made more than 60 days before the event will be subject to a \$200.00 change date fee. Date changes made less than 60 days before the event will be subject to a \$300.00 change date fee. Date changes are subject to entertainer's availability and may be considered a cancellation if entertainer is unavailable for new date.

CELEBRATIONS WILL USE ITS BEST EFFORTS TO TIMELY AND FULLY PERFORM UNDER THIS CONTRACT. HOWEVER, CLIENT UNDERSTANDS AND AGREES THAT CIRCUMSTANCES BEYOND THE CONTROL OF CELEBRATIONS AND ENTERTAINER MAY OCCUR WHEREBY CELEBRATIONS OR ENTERTAINER WILL BE UNABLE TO FULLY AND TIMELY PERFORM HEREUNDER AND CLIENT AGREES THAT NEITHER CELEBRATIONS NOR ENTERTAINER WILL BE RESPONSIBLE FOR ANY INCIDENTAL AND/OR CONSEQUENTIAL DAMAGES, INCLUDING EMOTIONAL DISTRESS, BECAUSE OF SUCH INABILITY TO PERFORM. FURTHER, CLIENT AGREES THAT ANY DAMAGES, CLAIMS OR LOSSES AGAINST CELEBRATIONS OR ENTERTAINER SHALL BE SOLELY LIMITED TO A PARTIAL OR TOTAL REFUND OF ANY AMOUNTS CLIENT HAS PAID UNDER THIS CONTRACT. If Event is delayed as a result of Celebrations or Entertainer, the Client will have the option to either extend the Event by the time delay or reduce the fee on a prorata basis according to the time lost. If Entertainer is unable to complete the Event, the fee will be paid on a prorata basis determined by the amount of the Event completed. This will not apply in the situation of damage to equipment or injury to Entertainer that is caused by persons or incidents at the Event.

This contract constitutes the entire agreement between the parties hereto and there are no promises, representations, nor warranties other than as set forth herein. No modifications of the terms of this contract will be valid unless recorded in a written amendment signed by all parties. The provisions of this contract are severable and if any provision of this contract is determined by a court to be invalid or unenforceable, the remaining provisions will remain in full force and effect. This contract shall be interpreted according to the laws of the state of California. Any lawsuit between the parties shall be filed and tried in the courts of the County of Orange, California. If this contract is breached by one of the parties, the court may award attorney's fees, court costs and related expenses to the other party.
